#### Freedom of Information – new procedures

NHSGGC is required to comply with the Freedom of Information (Scotland) Act 2002 (FOI), which legally requires us to respond to information requests from the public within 20 working days. Many staff across acute, partnership and corporate sites have a critical role to play in supporting this requirement by locating, preparing and providing information to the FOI team.

A <u>revised procedure</u> has been approved by the Corporate Management Team to ensure that everyone involved in the process is clear on what they are required to do and by when in order to help NHSGGC meet its legal timescales in responding to information requests. All staff are encouraged to familiarise themselves with this procedure should they be required to assist their management team.

Staff are also encouraged to complete the <u>LearnPro Module on Freedom of</u> Information.
