Data Security Spotlight – Business Email Compromise

A Business Email Compromise is an action a cyber-criminal undertakes to obtain access to a business email account and imitate the owner's identity. This can lead to emails coming into NHSGGC from organisations which have been compromised and in turn leading to compromise of accounts within the organisation. Whooping Cough (Pertussis) Vaccine - staff drop-in clinics this week

If you're in one of the following NHSGGC staff groups, you are urged to get your whooping cough (pertussis) vaccination at our drop-in sites in the coming weeks. This is to protect you and to avoid transmission to patients. No booking is necessary.

Priority vaccination groups:

1. Healthcare workers with regular/close clinical contact with severely ill infants (under 3 months old) and women in last month of pregnancy, including maternity, obstetrics, neonatal and paediatric intensive care
2. Healthcare workers with regular clinical contact with young unimmunised infants in hospital or community settings, such as other paediatric services and health visitors
3. Healthcare workers with intermittent clinical contact with young unimmunised infants in the community, including general practice.

Launch of Revised Peripheral Venous Catheter (PVC) Care Plan

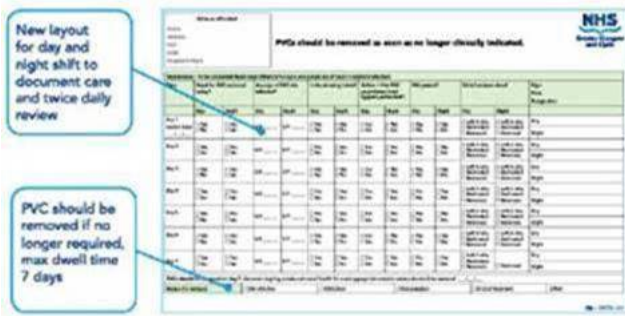
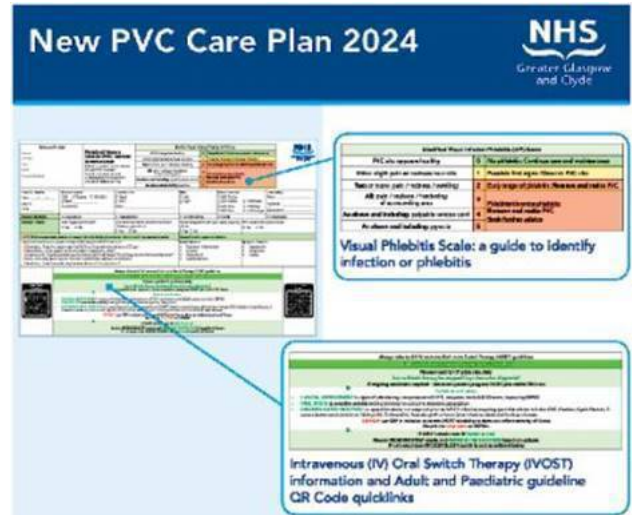
The changeover to the revised PVC Care Plan is planned across adult and paediatric hospitals for all **newly inserted PVCs from 00.01am on Monday 15 July 2024.**

The new PVC Care Plan can be ordered from **PECOS using code GGC0057.** Existing PVC Care Plans should continue to be used to document the care and maintenance of PVCs already in place at the switchover time, until the PVC is removed.

The main changes to the new care plan are:

- PVCs should be removed as soon as no longer required, with a maximum dwell time of seven days
- New layout for day and nightshift twice daily review

- QR code quick links for Adult & Paediatric IV Oral Switch Therapy (IVOST) guidelines.
- Two posters have been developed to raise awareness of the changes. These can be ordered from Medical Illustration using 354449 and 354448 respectively.

Learn Blood Transfusion (LBT) LearnPro modules

We are aware of an issue some staff have incurred following completion of the Learn Blood Transfusion (LBT) modules, specifically around modules not registering as complete. The issue appears to be across all modules. We would ask staff, in the first instance, to ensure they scroll to the bottom of the page once the assessment has been completed prior to closing the page. This may help resolve the issue in some cases.

We are working with the developers and hosting platforms to identify why this issue has occurred and we are trying to remedy this as quickly as possible. An incident has been raised within our Quality Management System.

In the meantime, we would ask staff to contact nss.lbtquery@nhs.scot to advise of any LBT modules that have been completed but not registering as completed.

We would like to take this time to apologise for any inconvenience this has caused and thank all users for their patience whilst we seek to resolve this issue.
