#### **North Sector SAB Group Update:**



The North Sector SAB group have been working to improve IVAD associated SABs with initiatives such as SAB education, Scrub the Hub posters and targeted improvement in 'hot spot' areas.

In January and February 2024 there have been no IVAD associated SABs. In addition, the North Sector has not breached the SAB aim since November 2023.

### **Clyde Sector SAB Group Update:**




There is good engagement and participation by all disciplines for the Clyde SAB Group. The group have agreed the following actions for PVC associated SABs —

- Following confirmation of a PVC associated SAB 4 weekly PVC sweeps and use of PVC
  Safety Cross by SCN, nurse in charge. IPCT support with tailored local education following
  discussion with SCN / LN e.g. ward based sessions discussing local data/outcomes/themes,
  attendance at morning huddles to discuss PVC on the ward, using working examples of
  compliance/non-compliance on PVC Care Plans and patient stories.
- Development of a Clyde PVC Care and Maintenance Poster Clyde Educators/IPCT
- IPCT Attendance at SCN Meetings to feedback local SAB data for discussion data provided by IPCT Data Team.
- PVC point prevalence across IRH and RAH across level 1,2 and 3 care areas, this was completed by critical care nurses, trainee ANPs and trainee ACCPs
- Review of shared learning of SAB cases following review by Cardiology ECMS Team RAH.

Development and trial of a new format A4 sheet to go in patients' notes to assist with patient management, investigation and assist surveillance with entry points of SABs. This A4 sheet will have a QR code to link to relevant documents – this will be piloted in ECMS at RAH and if successful will form a QI project.
