1. Scope

This procedure applies to all staff working within Glasgow Clinical Research Facility (GCRF).

2. Purpose

The purpose of this Standard Operating Procedure (SOP) is to define the responsibilities and procedure in the event of an adult and paediatric anaphylactic reaction in GCRF.

3. Procedures

- 3.1. In the event of an anaphylactic reaction with life threatening symptoms the current UK Resuscitation Council Anaphylaxis algorithm must be followed (appendix 1).
- 3.2. Participant experiencing mild rash/itch/swelling with no life threatening problems:
 - 3.2.1. Inform study doctor and get medical review.
 - 3.2.2. Consider Chlorphenamine (administer as prescribed).
 - 3.2.3. Consider Hydrocortisone (administer as prescribed).
 - 3.2.4. Continually assess.

3.3. All drugs are checked for expiry by a member of the nursing staff on a weekly basis. If patient progresses to Cardiac Arrest, initiate the Emergency Resuscitation Procedure as detailed in SOP 17.001 for adults and SOP 17.042 for paediatrics.


