3. Scope

Peer review is a Sponsor responsibility. Peer review is only required for non-commercial research studies, sponsored by NHS Greater Glasgow and Clyde (NHS GG&C), when the research is not supported by an eligible funder (Chief Scientist Office Eligible Funder list, Appendix 1) or is being processed via the national "extended review" system.

4. Purpose

Peer review provides a minimum quality check of the scientific methodology and feasibility of a research or innovation study. The UK Policy Framework for Health & Social Care states that 'Every proposal for health research must be subject to review by experts in the relevant fields able to offer independent advice on its quality'.

5. Procedures

5.1 Initiating peer review

Upon receipt of a protocol, the R&I Coordinator identifies at least one suitable reviewer for the project i.e. someone who works in an appropriate field of research, is independent of the project in question, and has no conflict of interest. The Research Administrator will liaise with the reviewer and collate any feedback.

The reviewer(s) is sent the following:

- A copy of the project protocol
- Any other relevant supporting documentation e.g. questionnaires
- A Peer Review Assessment Form (Form 51.003)

The papers are sent electronically and all documents are marked private and confidential. A deadline for reply of two calendar week's time is set.

5.2 Peer review outcome

The Peer reviewer may:

- Approve or reject the protocol if the project is not considered to be good value for money or if the research is not novel.
- Approve the protocol subject to amendments.
- Ask that the protocol is re-submitted to peer reviewers.

5.3 Resubmitting for Peer review

Protocols may be re-submitted for peer review more than once, if necessary, on condition that the reviewer's comments are addressed in the re-submission. Where amendments are made a new version of the protocol should be submitted by the Chief investigator (CI) to the R&I coordinator. The R&I coordinator will assess the amendments before re-submitting the protocol to the reviewer for approval. The Coordinator's Assistant will send the study team peer review feedback (anonymised) and will state if a resubmission of amended protocol is required.

5.4 Documenting Peer review

The results of the Peer review, and all documents pertaining to it, must be retained in the Sponsor file. For a student research project, review by the educational supervisor is normally considered adequate.

5.5 Timelines

If Peer review cannot be secured within the 15 day local Management Approval timeline set by the Chief Scientist Office, the Research Coordinator will submit the project to the R&I Committee for assessment. The Research Coordinator will present a synopsis of the research project to the group. Funding of the research project and logistics will be discussed and a decision will be documented, in the committee minute, confirming if the study can progress to full R&I approval.

5.6 Peer review process feedback

If the researcher is dissatisfied about any part of this process he/she should provide written details of their concern to the R&I coordinator, which will be reviewed by the R&I Committee. If the researcher is not satisfied with the response then he/she may seek advice from the R&I Director.
